Board of Trustees Annual General Meeting:

Trustees Annual Report for Period 2017 - 18

The Trustees of Health Care 4 All International present their annual report and audited accounts for the period 01 February 2017 and 31 January 2018, and confirm they comply with the requirements of the Charities Act 2011, the trust deed and the Charities SORP (FRS 102).

This report was agreed and accepted at the HC4AI AGM

Summary of Background and Aims:

Formed in 2014 Health Care 4 All International (HC4AI) is a totally 'not for profit' charity organisation registered with the charity commission UK and interior ministry and PCP in Pakistan as well as with the Kashmir Council and Societies. It is a small organisation that has no corporate backing and is funded solely by personal funding and individual supporters. Our services, including consultation, treatment, medicines and transport all are completely free to all deserving patients in the rural and remote communities.

HC4AI was registered as a charity on 8^{th} September 2014 (REGISTERED CHARITY NO. UK 1158474)

We aim to provide good quality, cost effective and easily accessible healthcare to the rural and remote communities who either have none or have very difficult access to healthcare. This will be provided via modified Telemedicine technique. To accomplish this we have developed a unique Novel Hybrid System of Telemedicine (NHST).

NHST is quite simple and basic; instead of providing telecom equipment to every household of the village and training them in its use it, we selected men and women from these villages with some medical background (nursing, Lady Health Visitors and Lady Health Workers,

paramedic, dispensers etc.), trained them in the use of technology and updated on routine and emergency medical practice, equipped them with tablet computers, downloaded it with our own indigenously developed Electronic Health Record (EHR) software and located them in a central place (The Base Unit-Monitoring Centre) from where they can reach any household in the village when called upon. In short they become the mouthpiece of the community, an interface between the community dwellers and the medical facility. We call them 'Community Health Workers' (CHW). These CHW's then communicate via video/audio link from the patients' home with the medical personnel who are located remotely. We provide the service non-stop 24 hours a day 365 days a year

Antenatal, and Neonatal Care, Health Awareness and Disease Prevention Programme

In addition to providing treatment we also work hard on registering all pregnant ladies on our EMR and follow them regularly throughout their pregnancy and birth and provide them information and assistance after delivery for both mother and baby.

We have now longstanding disease prevention and health awareness programmes for the communities.

Our CHW's, medical officers and visiting doctors (usually from abroad/UK) conduct this health awareness Programme.

We have three different programmes:

- 1. Community Health Awareness: Open for all community dwellers
- 2. Women's Health Awareness: For women of the communities in their homes
- 3. Children's Health Awareness: Conducted for children in schools.

Our Experience during 2017-2018

In 2014 we started the project as a pilot study covering a population of 3000 in villages of Mawa and Rarrah. However the success of the project was very apparent and the demand from the other remote communities was so overwhelming that the pilot study soon converted into full service provision. We soon expanded into surrounding villages at minimal extra cost and by the end of 2016 we were looking after a population of about 20,000.

In early 2017 we appointed a lady Doctor/Obstetrician and Gynaecologist and bought a portable digital ultrasound machine to provide antenatal care to all pregnant ladies in the communities.

In the autumn of 2018 we will InShaAllah be opening our second base monitoring centre at Chakswari that will expand our services to a population of around 50,000.

Consolidating Existing Services, Expanding services into new villages; Progress and other Achievements during 2017-2018:

This year has been the year of consolidating our services and maintaining the standards set from 2014 of quality care and reaching people in the very remote places. We experienced increasing number of calls from areas like Burjun, Durjun, Malote and few from as far as Sahar.

We also became the first to receive call in case of accident and emergency and at least on one occasion it was from as far as Pir Gali, which is really a long way from our centre, this was a major road traffic accident with a few fatalities, and our team helped with first aid to injured and their evacuation. We were also receiving calls from far out areas of Islamgarh and its New city.

This was also the year when we started expansion into neighboring areas. The need to do this was not only to provide health care to as many people as possible but also by increasing the catchment area (population base), without much increase in cost, we expect to bring down significantly the cost of providing the service per person per annum.

In 2017 we started building our second centre in Chakswari on a land with some skeleton shops donated by Mughal Brothers in memory of their father. The rebuilding and redecoration of this premises cost us around £35,000.00 that includes clinical equipment as well as office equipment and furniture.

This was the year when we paid special emphasis on maternal, ante and postnatal care for mothers to be as well as neonatal and childcare. Registering all pregnant ladies in the community and providing them with regular antenatal care became a priority. The intention was to predict any complications of pregnancy and delivery, as early as possible during the pregnancy, and to refer those where a problem is anticipated during the term or at delivery to specialized centres if and when needed. To accomplish this we appointed a lady doctor experienced in obstetrics and ultrasound operation and reading the result. We bought a digital portable ultrasound machine and developed antenatal check up cards, which the ladies carry with them, this records all the updated findings and observations at every consultation. We also started training our CHW's in the use of ultrasonography and care of ladies during their pregnancy and after delivery.

This was the year when we also renewed our old partnerships and forged some new ones.

A five-year contract for partnership and co-operation was renewed and signed by the Vice Chancellor of **Mirpur University of Science and Technology** (**MUST**) Dr Habib-Ur-Rehman and Chairman **HC4AI** Dr Tariq Shah at a

ceremony in Mirpur.

For a variety of reasons (mainly bureaucratic hurdles) the **Secretary of Health AJK** was unable to sign the renewed contract, although he visited the centre and was hugely impressed by our work; the file is still pending but the secretary has now retired, we will have to take it up with his replacement.

We also developed good working relationship and cooperation with Faculty of Healthcare and Medicines, school of applied sciences of Huddersfield University. We jointly wrote an article-editorial 'Health Care for all; effective, community supported healthcare with innovative use of 'telemedicine Technology' published in the peer reviewed Journal of Pharmaceutical Practice and Policy; shah et al. Journal of Pharmaceutical policy and practice (2018) 11.3 DOI 10.1186/s40545-018-0130-5

We also had promise of cooperation by Prof. Kelleher of **Digital Enterprise Zone Bradford University**, who has promised help in future exchange students Programme and in grant applications.

We also have technical and statistical analysis support provided by Mr Adam Hoare of **Bayswater Institute London**. He is also helping in future grant applications

This year we started HC4Al's regular newsletter through Mailchimp. Mr Steve Davison of **Mediate First** is the editor. He also continues to provide unconditional support and advice not only in promotion and awareness of our charity but also mediates as well as prepares complicated future projection proposals for grant applications.

Although we have spent enormous sums of money to perfect the NHST for video consultations, the terrain is very tough and we still can't get connectivity with enough bandwidth and speed for good two-way video call from some of the remotely located patients home and the base. In such instance we resort to audio calling. We are awaiting the promised 3G and 4G signals availability in the areas of our operations, this should hopefully alleviate this problem.

This year we have also ordered at an extremely discounted price an EMR system that is built locally with its own video platform and apps for live transfer of patients clinical parameters and information. We expect it to go live this year. For security and maintaining confidentiality we have also purchased our own Servers, located at MUST. This will also provide us an intranet facility and will be extremely helpful in audits and data analyses.

The cost of this new, much improved EMR system with the apps and video platform and the servers is around £ 15,000.00.

Following is a summary of some of our accomplishments this year:

- Started construction of second centre Base Unit/Monitoring Centre at Chakswari. This will increase our catchment area population to approximately 50,000 spread in dozens of small villages
- 2. Purchase of a more robust Electronic Medical Records (EMR) System and video platform for improved video link between field and base
- Purchase of our own Electronic Data Servers located at Mirpur University
 of Science and Technology for securing data and analysis and intranet
 connectivity
- 4. Purchase of all necessary clinical and office equipment for the new centre
- 5. Purchase of two AED (Automatic Electrical Defibrillators) one to be located in the new centre and the other in the ambulance
- 6. Arrangement of residential facilities for staff at the new Chakswari Centre
- 7. Generators and UPS for the new centre electrical backup
- 8. Improved Laboratory facilities with purchase of biochemistry & haematology analyzer
- 9. Extension of lab services in the outreach to provide screening service
- 10. Extended inventory of the pharmacy
- 11. Appointment of a female lab technician
- 12. Appointment of female medical officer with experience in obstetrics & gynaecology. And training of female CHW's for antenatal, postnatal and neonatal care in the community, including performing the ultrasound scan.
- 13. Continuing antenatal and postnatal care for all pregnant ladies in the community
- 14. Appointment of new female IT and admin supervisor
- 15. Continuing Health Awareness programs for the communities
- 16. Started regular newsletter on Mailchimp
- 17. Started second evaluation of service and second clinical audit and service satisfaction survey of the community to be complete by early 2019

NOTES TO THE FINANCIAL STATEMENTS FOR YEAR ENDED 30 JUNE 2018

The Organization and Its

1 Operations

- 1.1 The Society was registered under the Society Registration Act, 1860 as a Non Profit Organization (NPO) by the name of HEALTH CARE 4 ALL INTERNATIONAL (HC4AI). The registered office of the Society is situated at State of Azad Jammu & Kashmir.
- 1.2 The principal objective of the HC4AI is to provide health care, facilitation by use of Tele Medicine and Tele Health technology through a network of Community Health Worker (CHW) to remote rural communities in Azad Jammu & Kashmir (AJ&K) and Pakistan who otherwise do not have easy or any access to health emphasis on maternal and child health and prevention of diseases.

In 2014 we started from villages of Mawa Rarrah with our monitoring centre at Rarrah Welfare Hospital serving approximately 10-15,0000 population.

In 2017 we initiated building of our second monitoring centre/Base Unit at Chakswari, this will boast the population we serve to approximately 50,000 and includes dozens of small remote villages

Summary of Significant Accounting

2- Policies

2.1- Accounting Convention

These Financial statements have been prepared under the historical cost convention, except for measurement of certain financial instrument at fair value.

2.2- Trade and other Payables

Liabilities for trade and other amounts payable are carried at cost which is the fair value of the consideration to be paid in the future for goods and services received, whether or not billed to the Organization.

2.3- Fixed Assets

Fixed Assets are stated at cost less accumulated depreciation at the rate indicated in Note No. 5. Depreciation is charged through application of reducing balance method. Full depreciation is charged in the year of acquisition of an asset and no depreciation is charged in the year of disposal. Major renewals and improvement are capitalized.

2.4- Taxation

The tax charged under clause 36 of section 2 of the Income Tax Ordinance 2001, by taking into account the current Income Tax Laws and recognized in the Income & Expenditure Account. The law allows a tax credit equal to 100% of the tax payable, including minimum tax and final taxes payable under any of the provisions.

2.5- Cash and Bank Balance

Cash in hand and cash at bank are carried at cost.
